# FORMAL CONSIDERATION OF ANNUAL REPORT 2019/20

### BACKGROUND

Under Section 131 of *the Local Government Act 1989* (the Act 1989), Council is required to prepare and submit an Annual Report to the Minister for Local Government within three months of the end of each financial year. The 2019/20 Annual Report was submitted to the Minister on 22 September 2020.

Section 134 of *the Act 1989* also requires Council to hold a meeting to consider the report within one month of submission to the Minister. This meeting is required to be an open meeting and at least 14 days' notice must be given. Such notice was given in The Age newspaper on 23 September 2020.

### **ISSUE / DISCUSSION**

Council endorsed the Annual Report 2019/20 for submission to the Minister at its meeting held on 21 September 2020 and a copy of the report was subsequently forwarded to the Minister for Local Government on 22 September 2020.

The necessary statutory advertising has been undertaken and copies of the report have been made available from Council Service Centres and Council's website.

Key features of the Annual Report as required by section 131 of *the Act 1989* include the following:

- A report of Council's operations during the financial year
- Audited financial statements for the financial year
- Performance Statement prepared under Section 132
- Report on the Performance Statement prepared under Section 133
- Inclusion of Council results relating to the Local Government Performance Reporting Framework for the 2019/20 financial year

The report demonstrates Council's ongoing commitment to the Maroondah community and highlights a range of achievements. During 2019/20, Council:

- Completed construction of the \$4.25m HE Parker Sporting Pavilion in Heathmont
- Undertook a strategic review of golf in Maroondah, including a new Maroondah Golf Strategy
- Delivered the Be Kind Maroondah campaign
- Promoted and expanded membership of the BizHub Co-Working Space at Realm, and provided support to small businesses during the COVID-19 pandemic
- Worked in partnership to implement the Bayswater Business Precinct Strategy, including launch of the *BBP Connect* social platform and *BBP Jobs* platform
- Adopted a new Arts and Cultural Development Strategy 2020-2025
- Hosted Karralyka performances online during the COVID-19 pandemic
- Adopted the Maroondah Vegetation Strategy 2020-2030
- Undertook renewal works on the Dandenong Creek shared trail and constructed 3.49 kilometres of new footpaths
- Commenced the design of multi-level carparks in Croydon, Ringwood, Heathmont and at Heatherdale Station
- Completed the Lincoln Road upgrade in Croydon
- Implemented the new Ringwood Activity Centre Masterplan into planning processes

- Progressed the Croydon Community Wellbeing Precinct Masterplan
- Worked in partnership to implement the Tarralla Creek Connects project

- Provided support for older people, vulnerable residents and linguistically and culturally diverse groups during COVID-19
- Reviewed Maroondah 2040 'Our future together'
- Implemented a COVID-19 relief and recovery response framework
- Implemented the new Local Government Act 2020
