"Twisted Fate: Tara Denny event: The artist bears the bulk of the cost for delivering their own exhibition in this space. Curatorial and marketing support (in-kind), and modest launch catering, total cost to Council of \$275 as part of the annual arts budget.

Grounding and Connecting: Indigenous Trees and The Dreaming exhibition. Mullum Mullum Indigenous Gather Place developed and largely funded this exhibition program via a State Government grant in consultation with the Eastern Region Group of Councils - Boroondara, Knox, Manningham, Monash, Whitehorse and Yarra Ranges. Maroondah City Council supported the Maroondah part of the exhibition in-kind through curation and marketing, and co-funded the design, printing and launch event costs to the total value of \$8,635, as part of the annual arts budget.

The Arts Lounge Exhibition - Natalie Wijeyeratne and Denise Bond" The artists bear the bulk of the cost for delivering their own exhibition in this space as well. Some curatorial, program management and marketing support is offered by Council in-kind, and Council also receives a 25% commission from sales to help cover the in-kind contributions."
