They seem to spray when its windy too so it spreads. They are children around too, very concerning."

"Bayswater Road is an Arterial Road and is maintained and managed by the Department of Transport and Planning (or DTP). Council Maintains and manages parts of the roadside areas, and this includes weed spraying using glyphosate in accordance with the guidelines and requirements of Worksafe Victoria and the Australian Pesticides and Veterinary Medicines Authority (APVMA). DTP also undertakes weed spraying in parts of the roadside, and Council Officers are currently liaising with them to facilitate a response to the previous enquiries regarding this matter"
